This letter is in response to the request of Hylife-Crown Royal Nursery 2 (TRC-12-091) to establish a nursery pig operation at SE $\frac{1}{4}$ 33-03-16 WPM within the RM of Killarney-Turtle Mountain.

We strongly oppose this factory being established at the proposed location. We currently own 80 acres of land (SE ½ 28-3-16) with our house being one mile south of the proposed factory and our property line being only half a mile. My husband and I purchased our farm over a decade ago to enjoy the space and health that country living provides. We have since welcomed three children into our family and take great pride in our home and surrounding land.

Not unlike many in our areas, we are baffled to imagine a government, municipal or provincial that would consider these types of concentrated animal feeding operations a viable and thoughtful response to job creation or an improved economy. These pig factories only ensure that foreign corporations profit once again on the back of rural communities. These global companies offer questionable economic returns in return for environmental degradation, risks to local aquifers, lakes and rivers and decreased property values.

Having reviewed the Site Assessment submitted by the applicant it cannot be determined if a complete and accurate environmental impact assessment has been conducted and reviewed. Limited information has been released but even that small amount of information raises red flags.

7.1 Water Requirements

The Site Assessment states that the water (implied as fresh water) required for the operation is estimated at a maximum of 19,800 Imperial gallons per day or 7,227,000 Imperial gallons per year. The operational need is proposed to be supplied by a nearby well (SE-33-3-16W). Given the well is on an aquifer that also supplies the nearby community well to the west, the town of Killarney and already operating farms and residents, what is the specific and science-based impact on the water availability for the area? I am concerned for the depletion and possible contamination of water sources despite promises of safeguarding environmental conditions.

11.0 Odour Control Measures

Hylife has actually stopped pretending to even try to reduce the highly offensive gases from spreading by omitting the manure storage cover from their list of preventative measures. This could be because they don't work, rip, blow off, etc and have had issues in the past with their promises otherwise. Polluting the air with the stench from this factory cannot be avoided with a 180,600 square foot uncovered lagoon. The Site Assessment did check off that they will have shelterbelt planting which is sounds promising in theory only. It will take decades to grow a decent shelterbelt and that is if all the environmental conditions are favorable. It won't be in my lifetime or yours that these proposed trees will actually decrease the smell from travelling when the winds blow. This pig factory reduces the quality of life for those in the vicinity causing windows to remain closed, and outdoor leisure time to be limited due to odor.

Any taxes gained will be promptly spent on gravelling and maintaining the roads. Our municipality will have a hard time arguing this point according to their books. Hylife will tear up the roads with their trucks every day, and although The Site Assessment may state that they will drive the provincial highway 253, chances are they won't when road restrictions are off. Undoubtably, they will go straight south to the feed mill on 94W, passing the school bus that our children are on and dusting out anyone who dares to be on their pedal bikes, or trying to enjoy what was once our clean country air.

If this proposal was a neighbor trying to support a family and living in the same yard as the barn, we would be supportive and respect would be had. Instead the benefits of this factory are limited to the one individual who is selling the land and using the fertilizer for his land, the few people who will be hired to work at this automated hog factory and local farmers who sell their grain as feed to the already abundant number of hog barns in the area.

The negative consequences of foreign owned pig barn operations far outweigh any perceived economic benefit to a community. This company is pushing into our community to utilize our resources. The stench of the barns and associated pollution of fields and nearby waterways is detrimental to the lifestyle of the local tax paying citizens.

Lastly, this proposal is for a three-barn operation of 18,000 pigs with a large lagoon. It has not been overlooked that the size of the lagoon is decent and it would be hard not to speculate that in a few years there may well be an expansion thus causing more depletion of water resources and an increase in smell.

We are dreading the impending odour of this intended barn, as well as the other environmental impacts that will affect all of us in the area for miles. I wish prosperity to all, but it does appear that those of us who fall into the catchment area of this factory, now owned by non-Canadian investors get to pay the price.

Regarding the HyLife swine nursery barn proposal for SE33-3-16 W1 (they call it "Crown Royal" without license?)

- 1. Move site away from public highway as far as possible to reduce H2S poisonings.
- Neurotoxic heavier than air hydrogen sulfide H2S gas will be released from uncovered open pig excrement slurry pit close beside and above highway, and drawn into vehicles including school bus, or deep inhaled by cyclists, yet there is no continuous H2S hazard monitoring adjacent to road nor electronic signage on highway, nor even a "warning, risk of H2S, hold your breath" danger signage. This negligence to protect the public from neurotoxin seems merely to avoid cost of constructing a longer farm lane.

- 2. Do not store liquid pig excrement (manure) during summer, to reduce H2S creation.
- Fermenting of anaerobic manure producing H2S during hot long summer storage is wholly unnecessary, when land owners, having shared liability for H2S poisoning on staff and public, ought to be banding the pig excrement under protective soil directly from barns every day when soil is dry. Farmers can easily responsibly band pig excrement into row crop corn until late summer, for example, or into a green cover crop which functions also to eliminate crop diseases and herbicideresistant weeds during the fertility building summer. The excess sulfur in the excrement from which H2S in produced, originates in both the avoidable imbalance of amino acids if excess sulfur-rich cheap distillers dry grains is used, and in sulfurous well water added during floor washing.
- No conveyance of liquid excrement across the Pembina River valley.
- To prevent risk of pollution of Pelican Lake with phosphorus feeding neurotoxic cyanobacteria.
- There is no plan preventing eventual piercing or rupture of a liquid manure conveyance hoze, nor mention of yearly replacing of sensors and automatic shut-off valves such as if was a petroleum pipeline, nor are there mortgage caveats on the farm lands to provide funds for remediation when a

lake polluting event occurs.

- 4. Ultraviolet light sanitation of viruses in barn fan air.
- To each barn fan, add cyclones to first remove dust particles, then eg.biochar air filtration to lower polar and odorous and viral compounds, then UV treatment critical after sundown to eliminate all residual viable virus aerosols.
- Pathogenic virus aerosols, such as the 1918 swine flu pandemic of swine and humans, are now fan exhausted all night with no sanitizing UV exposure from sunlight, thus contagion risk from swine is now very much higher than in 1918, inhaled by all within each passing vehicle on Hwy 253, and into open windows of bedrooms in Killarney. If the pig odour can be smelled, then the drift carrying it can also contain pathogenic viruses during darkness.

- 5. Enable workers' self protection by democracy.
- Implement annual democratic secret preference-ranked ballot election by all workers, of the chief operating officer, due to this proposal for a H2S neurotoxin producing, and risk of pathogenic virus propagating, facility having insufficient provisions for worker and public protection from these hazards. Similar to Kremlin, failure to protect persons from predictable harm possibly indicates leadership/ownership as incompetent or unempathetic.
- This is not a local worker-controlled business self-motivated to protect workers and residents from neurotoxic H2S and epidemic viruses, in a province and municipality who have knowingly ignored public health science for 17 years. Need for immigration sourced staffing confirms the jobs are sub-Canadian desirability, and suspect for safety deficiency given standards may be lower where immigrants sourced from, and due to the indentured dependency of immigrant staff and consequent inability to speak up to insist on own protection from all potential hazards.
- Given that science-known neurotoxins and viruses are possibly present outside of barns when downwind from fans and slurry pit, workers must always arrive and leave site in fully enclosed vehicles with recirculated air, and never work outside wherever odour is present, given neurotoxins and viruses might lurk within odour.
- 6. Document trade mark license agreement if any obtained by HyLife for use of "Crown Royal" trade mark, or immediately cease usage due to destruction of a long established Manitoba product brand by negative association.
- All other sites operated by the company ought similarly be renamed with honesty such as this one to be renamed as "HyLife Swine Nursery SE33-3-16 W1", to avoid negative impact on products of other industries, of negatively impacting the marketings and profit paid to our government of our public-owned Manitoba Liquor Marts, of image communities or of family farm names, by association with vile odors and neurotoxin production, and to end using suggestive names possibly to psychologically masquerade vile odour as though it is lovely bouquet, misleading the public about possible aerosolized pathogens and the toxic gases emitted.

I have received direct high quality testimony from a member of the public who this past fall experienced neurological impact of confusion and dizzyness from hydrogen sulfide originating from a swine manure storage from swine fed by HyLife's feed mill, at much greater distance that this proposed facility is to be from public highway #253 in Manitoba.

Our grandson [7 years old] loves being at the lake and enjoying the water. Over the years many efforts have been made to try to improve the quality of the lake water. At the same time there have been occurrences that dramatically decreased the quality of the lake. Overflows from the municipal lagoon, drainage tile being installed in fields that drain into the lake and the ongoing constant clearing of any existing bush adjacent to the lake all cause deterioration in the quality of the lake water to the point where it is sometimes a danger to a person's health and well being to be exposed to the lake water.

The proposal for a large hog barn and disposal of the subsequent waste is very near the Pembina river water shed. The Pembina river is used to add water to Pelican lake to bring it to a normal level. This water is added to the lake when the Pembina river is running at a high level, i.e. during spring melt and run off season. That is the time of year when nutrients from the disposal of pig waste is likely to get into the Pembina river. Please relocate this proposed operation to a location where there is absolutely no danger of it deteriorating our water resources any more than they already are.
