CODE OF CONDUCT INVESTIGATION AND MEDIATION SERVICES

The new code of conduct legislative framework came into force on November 1, 2020. The framework outlines a standardized complaint resolution process, including steps to refer complaints to mediation and/or investigation. To support municipalities in addressing code of conduct complaints, Municipal Relations is providing lists of available investigation and mediation service providers (attached).

A competitive process was undertaken to identify available service providers. The attached lists detail mediation and investigation service providers available in each of the Association of Manitoba Municipalities' seven provincial districts.
