

**NOTICE OF PUBLIC HEARING
BY THE MUNICIPAL BOARD OF MANITOBA**

**RE: RURAL MUNICIPALITY OF SPRINGFIELD – ZONING BY-LAW NO. 08-01
FILE NOS. 22B3-0007 AND 23B6-0001**

IN THE MATTER OF: Request from Legal Counsel for Sio Silica Corporation (the “Owner”) that the Board make a clarifying correction to the legal description of the subject lands as defined in Board Order No. B-23-001 (the “Order”).

AND IN THE MATTER OF: Appeal by the Owner of the failure of the Rural Municipality of Springfield to conclude a Development Agreement within 90 days after the agreement is required, as per Section 151.0.1 of *The Planning Act*.

PUBLIC NOTICE is hereby given that, under the provisions of *The Planning Act*, C.C.S.M. c. P80, and *The Municipal Board Act*, C.C.S.M. c. M240, the Board will hold a public hearing to receive representations from any person regarding the subject matters.

The public hearing will take place on **Monday, October 23**, and, if needed, on **Tuesday, October 24** and **Wednesday, October 25, 2023** at **9:30 a.m.** at the **Dugald Community Club, 544 Holland Street, Dugald, Manitoba.**

Any person may make a representation on the matters to be considered at the hearing. A person who wishes to make a written and/or oral presentation to the Board must register by filing a completed Public Presenter Form with the Board at least ten (10) working days prior to the hearing.

The Board requires that a person who intends on filing a written submission must file four (4) copies of that material with the Board and one (1) copy with the Rural Municipality of Springfield for public viewing at least ten (10) working days prior to the hearing, failing which copies of the written submission must be provided to the Board and the parties at the hearing.
