WHO WE ARE

The Manitoba Conservation Officer Service employs patrol officers on a seasonal basis (approx. 17 weeks) to provide safety and security within Manitoba's provincial parks and enforce natural resource rules throughout the province. Patrol officers promote enjoyment for park visitors and protect the natural resources through education, infraction prevention, and enforcement. Patrol officers are the first point of contact between the department and the public and can be faced with a variety of situations ranging from general inquiries to dealing with enforcement matters.

WHAT WE DO

- patrol by foot, bicycle or vehicle and be a contact for the public within the park
- inform and educate the public
- act on complaints about individuals whose conduct is deemed inappropriate, unsafe, or illegal
- issue paperwork pertaining to enforcement situations
- evict non-compliant park users
- conduct crowd control at incidents, accidents or special events
- assist in searches of lost persons and provide first aid when needed
- assist conservation officers with other duties such as problem wildlife, wildfire duties, and emergency situations



WHERE WE WORK

Patrol officers are stationed within provincial parks throughout Manitoba.

WHEN DOES SEASONAL WORK TAKE PLACE?

Work begins each year from May and runs until the end of August.

If you are looking for a career in conservation or law enforcement, this is a great place to start! Patrol officers must complete a mandatory 10-day training course where they will learn the skills needed to become an officer and deal with the public. Patrol officers will take courses on conflict resolution, search and seizure, powers of arrest, enforcement forms, defensive tactics and use of force to name a few.



WHAT QUALIFICATIONS DO YOU NEED?

You will need:

- to have completed year one of a recognized Resource Management diploma or degree program, or be a graduate from a recognized law enforcement diploma program or Police Studies program; or have completed year two of an undergraduate degree in the studies of Law, Environmental Studies/Sciences, with a minimum of three credit hours of law courses satisfactory to the department, or; an equivalent combination of education, training and experience satisfactory to the department
- the ability to make decisions and problem solve
- the ability to work effectively under stress in hostile or adverse environmental conditions
- good verbal communication and presentation skills
- the ability to work in a team environment
- the ability to work independently under limited supervision with good time management skills
- good written communication skills
