OVERVIEW:

A proposal has been filed by Mr. James Hackl on behalf of Millennium Cylinder Technologies Ltd. for the construction and operation of a manufacturing development located near Stony Mountain in Lot 2 Plan 19654 pt. SE ¼ 10-13-2 EPM in the Rural Municipality of Rockwood. The development involves the reconditioning of engine cylinder bores. Production processes involve removing old plating and nickel/silicon carbide replating by electrolysis, and honing the replated bores. There is a potential for emissions of particulate matter and vapour. Normal operation is 40 hours per week, 50 weeks per year.

The Department provided the Technical Advisory Committee with information on the Proposal and made public notification in the Stonewall Argus. The following summarizes the responses:

 - c) on-site incineration of anything must first be registered/authorized under the Incinerator Reg;
 - d) consider having noise restrictions in place;
 - e) welding and paint fumes are expected;
 - f) sewerage will be to the Village lagoon system we might stipulate that it be restricted to human/domestic wastes only.

Item e) There may be some particulate emitted from the limited welding. Painting has been proposed as a possible future activity. Potential odours are addressed in the licence.
