THIS LICENCE IS ISSUED TO:

(BAKERS NARROWS/FLIN FLON RECREATIONAL AREA - WASTEWATER TREATMENT LAGOON)

The following limits, terms, and conditions shall be considered in connection with the construction and operation asstrate treatment lagoon located on Section 24-66-29W with displarge or treatment effluent to Little Spruce Lake:

- 1. The Applicant shall ensure that all diestic sew ge generated in the regional cottage and recreational areas is discharged into the primary cell of the wastewater treatment of is discharged to another licenced wastewater treatment facility.
- 2. The Applicant shall not dischare efficient from the wastewater treatment lagoon:
 - (a) where the organic content of the effluent, as indicated by the five day blocher cal oxy an demand, is in excess of 30 milligrams per lity.
 - (b) where the stall liform content of the effluent, as indicated by the MPN index, it in excess of 200 per 100 millilitres of sample;
 - (c) where the total coliform content of the effluent, as indicated by he APN index, is in excess of 1500 per 100 millilitres of sample;
 - (d) bether the 1st day of November of any year and the 15th day of Ma, of the following year, unless prior approval, by the ctor, is given.
- 3. Applicant shall operate and maintain the wastewater treatment lagoon in uch a manner that:
 - (a) the release of offensive odours is minimized;

- (b) the organic loading on the primary cell of the lagoon system, as indicated by the five day biochemical oxygen demand, is not in excess of 56 kilograms per hectare per day;
- (c) the depth of sewage in the primary cell does not exceed 1.5 metres.
- 4. The Applicant shall, in case of physical or mechanical bound of the wastewater collection and/or treatment system:
 - (a) notify the Director immediately;
 - (b) identify the repairs required to the was swater collection and/or treatment system;
 - (c) complete the repairs in accordance the written instructions of the Director.
- 5. The Applicant shall prior to the construction of the wastewater treatment lagoon:
 - (a) remove all surface con and obris from the lagoon site;
 - (b) ensure that all aban med ine shafts are properly sealed and capped; and
 - (c) ensure that the base mater 1 does not contain any large voids, with the exception of the abandoned mine shafts, which might cause settlement of the lagora structure and/or damage to the clay liner.
- or other surface material such that all interior surfaces of the lagoon structure are lined ith a minimum of 1 metre of soil having a hydraulic correctivity of 10-7 centimetres per second or less.
- 7. The Applicant shall arrange with the designated Environment Officer a mount acceptable time and date for any required soil sampling between the 15th by of May and the 1st day of November of any year, unless approval, by the Director, is given.
- 8. The Applicant shall either:
 - (a) subject undisturbed soil samples from the completed wastewater treatment lagoon to hydraulic conductivity tests, the number and location of said samples to be specified by an Environment Officer up to maximum of twenty samples; or

- (b) where undisturbed soil samples cannot be taken, test the soil of 4 plane surfaces from the wastewater treatment lagoon for hydraulic conductivity by an insitu field test method as prescribed by an Environment Officer.
- 9. The Applicant shall, not less than 2 weeks before the wastewater treatment lagoon is placed in operation, submit to the Director the results of the tests carried out pursuant to Clause 8.
- 10. The Applicant shall utilize, install, and maintain a commission embankments, natural barriers, and fences around the wash water treatment lagoon to limit access.
- 11. The Applicant shall ensure that treated effluent is no discharged toward the mine tailings area.
