# UNITED PACIFIC COMPANY LTD.: APPLICANT

The following limits, terms and conditions shall be complied with by United Pacific Company Ltd., in connection with the operation of a pharmaceutical processing plant located at 921 Douglas Street on Lot 19, Plan 1489 BLTO, in Section 13-10-19 WPM, in the City of Brandon.

### LIQUID DISCHARGES

- 1. The Applicant shall dispose of liquid wastes from the said operation, other than organic chemicals and/or waste pharmaceutical products, only into Brandon's municipal sewage collection system.
- 2. The Applicant shall dispose of any organic chemicals and/or waste pharmaceutical products, not reused at this operation, only in a manner acceptable to the Director.
- 3. The Applicant shall notify the Director of any chemical spills either within or outside of the processing plant, within 24 hours of such an event.

### AIR EMISSIONS

- 4. The Applicant shall limit odour emissions to such an extent that at any point of impingement off the site of the operation, odours emanating from the operation are not detectable:
  - a) in a residential area or commercial area when one volume of odorous air is diluted with one equal volume of odour-free air;
  - b) in an industrial area when one volume of odorous air is diluted with six equal volumes of odour-free air.

# SOLID WASTE DISPOSAL

5. The Applicant shall dispose of the accumulated processed gall bladders at least weekly and only to a rendering plant.

6. The Applicant shall, within two months of the date of issue of this Licence, submit to the Director, for approval, a contingency plan for the alternative disposal of the processed gall bladders at another rendering plant in the event that the Rothsay rendering plant in Brandon is temporarily unable to accommodate the acceptance of the processed gall bladders.

### **GENERAL**

- 7. The Applicant shall maintain the highest practical level of recycling of process chemicals so as to minimize their loss to the sewerage system and/or to the atmosphere.
- 8. The Applicant shall ensure that a high standard of process equipment maintenance and good housekeeping practices are carried out at all times consistent with meeting the requirements of this Licence.
- 9. The Applicant shall ensure that no adverse public health or nuisance condition is created on the plant property.
- 10. The Applicant shall, if and when requested by the Director, investigate specific areas of concern regarding any aspects of the solids, liquid waste and air emissions handling, containment, treatment, recycling and disposal systems associated with the operation, and provide the Director with such engineering studies, drawings, and specifications, analyses of wastewater streams, air emission qualities, discharge or emission rates, and such other information as may be requested.
