In accordance with the Manitoba Environment Act (C.C.S.M. c. E125)

THIS LICENCE IS ISSUED TO:

THE BLUMENFELD-HOCHFELD WATER COOP: "the Licencee"

for the construction and operation of the Development being a municipal water distribution project in the Osterwick and Haskett areas in the Rural Municipality of Stanley subject to the following specifications, limits, terms and conditions:

SPECIFICATIONS, LIMITS, TERMS AND CONDITIONS

- 1. The Licencee shall construct the Development in accordance with The Environment Act Proposal dated May 23, 1995, and submitted by PFRA on behalf of the Licencee.
- 2. The Licencee shall construct crossings of Provincial Waterways and any other waterways containing standing water at the time of construction by boring, tunnelling or augering under the waterway as described in the Proposal. The Licencee shall not undertake any method of waterway crossing other than that authorized by this Licence without prior written approval from the Director.
- 3. The Licencee shall stabilize and re-vegetate any areas of soil disturbed by the construction of the Development which could be invaded by noxious weeds or which could erode and produce sedimentation in waterways.
- 4. The Licencee shall obtain all necessary permits and agreements from Manitoba Highways and Transportation and the Highway Traffic Board prior to undertaking construction on or adjacent to highway rights-of-way.
- 5. The Licencee shall install pipelines in the community of Osterwick using trenching techniques.
- 6. The Licencee shall ensure that approved backflow prevention devices are installed where necessary to prevent cross-connections between the Development and existing private water supply systems.
- 7. The Licencee shall, prior to the commencement of construction of the Development, submit detailed construction drawings for the approval of the Director.
- 8. The Licencee shall ensure that the operation of the municipal water supply is in accordance with Manitoba Regulations under The Public Health Act and all operating requirements as recommended by Manitoba Environment.

- 9. The Licencee shall ensure that all used oil products and other regulated hazardous wastes generated by the machinery used in the construction of the Development are collected and disposed of in accordance with all applicable Manitoba Environment and legislation requirements.
- 10. The Licencee shall ensure that fuel storage areas established for the construction of the Development shall comply with the requirements of Manitoba Regulation 97/88R respecting Storage and Handling of Gasoline and Associated Products.

REVOCATION

If, in the opinion of the Director, the Licencee has exceeded or is exceeding the limits, or has not complied or is not complying with the specifications, terms or conditions set out herein, the Director may revoke this Licence either temporarily or permanently.
