AN ORDER OF THE CLEAN ENVIRONMENT COMMISSION

UNDER THE CLEAN ENVIRONMENT ACT

The Clean Environment Commission and Building Products of Canada Limited, applicant,

pursuant to the provisions of The Clean Environment Act, Building WHEREAS Products of Canada Limited has submitted an application to the Clean Environment Commission to prescribe limits in connection with the operation of a paper mill, roofing mill and asphalt storage area located at 2 Point Douglas Road, in the City of Winnipeg,

AND WHEREAS representations were made to the Clean Environment Commission by persons who are or are likely to be affected by an Order of the Commission prescribing limits in connection with the said operation,

the Clean Environment Commission held a public hearing on the 6th AND WHEREAS day of May, 1974 in the Board Room of Building 2, Fort Osborne Complex, Winnipeg, Manitoba at which two Commissioners heard evidence in connection with the application,

the Clean Environment Commission, having received a certified copy of AND WHEREAS the transcript of the evidence taken at the said hearing, considered the application on the 3rd day of June, 1974,

IT IS HEREBY ORDERED THAT

The applicant shall ensure that within eighteen months from the date of issuance of this Order:

- emissions from the said operation are limited:
 - (a) with respect to particulate matter to a maximum of 0.57 grams per standard cubic meter of air calculated at 20 degrees Centigrade and 760 millimeters of mercury (0.25 grains per standard cubic foot),
 - (b) with respect to smoke to a density of not more than number two on the Ringelmann Smoke Chart for a period or periods totalling not more than four minutes in one
- 2. at any point of impingement off the site of the said operation:

 (a) odour does not exceed seven dilutions to threshhold as determined with a Scentometer by the Environmental Management Division of the Department and Environmental Management Division of the Department of Mines, Resources and Environmental Management or by any other agency the Minister of the said Department may stipulate for this purpose,

- (b) the dustfall over a period of thirty days does not exceed 1.5 milligrams per square centimeter over and above the background level,
- (c) the suspended particulates content does not exceed an average concentration of 100 micrograms per cubic meter of air over a twenty-four hour period,
- 3. the average dustfall in the air basin off and around the site of the said operation over a period of thirty days does not exceed 0.8 milligrams per square centimeter over and above the background level.
