AN ORDER OF THE CLEAN ENVIRONMENT COMMISSION

UNDER THE CLEAN ENVIRONMENT ACT

RE: THE CLEAN ENVIRONMENT COMMISSION and DEERWOOD ELEVATOR LTD., Applicant,

WHEREAS pursuant to the provisions of The Clean Environment Act, Deerwood Elevator Ltd. filed a proposal with the Department of Mines, Resources and Environmental Management in connection with the operation of a seed cleaning plant located on the SW4 of Section 31, Range 6, Township 4 WPM in the Rural Municipality of Dufferin, Manitoba;

- AND WHEREAS in the absence of limits being prescribed by a Regulation under the said Act, the said proposal was referred to The Clean Environment Commission for the prescribing of limits;
- AND WHEREAS no representation was made to the Commission by any person who is or who is likely to be affected by an Order of the Commission prescribing limits in connection with the said operation;
- AND WHEREAS the Commission considered the proposal on the 10th day of October, 1978;

IT IS HEREBY ORDERED THAT

- 1. The Applicant shall ensure that particulate emissions from the various processes of the said seed cleaning plant are not in excess of 0.23 grams per standard cubic meter calculated at 25 degrees Celsius and 760 millimeters of mercury, at the point of emission.
- 2. The Applicant shall ensure that particulate matter from any source of the said operation does not become airborne to such an extent that particulate matter remains visible past the property line of the said operation.

- 3. The Applicant shall ensure that sound emissions from the said operation, measured beyond the property line of the said operation and within 15 meters of a residence, do not result in sound levels* in excess of:
 - (a) 60 dBA during the daytime hours of 7:00 a.m. to 10:00 p.m., local time, or
 - (b) 50 dBA during the nighttime hours of 10:00 p.m. to 7:00 a.m., local time.
- 4. The Applicant shall ensure that a high standard of good housekeeping practices and equipment maintenance is carried out at all times in order to meet the limits set out in Clauses 1, 2 and 3 of this Order.
