Re: South End Water Pollution Control Centre – Environment Act Licence No. 2716 RR – Notice of Alteration Approval

Thank you for your Notice of Alteration to Environment Act Licence No. 2716 RR received on July 3, 2025, and additional information received on July 24, 2025. Your request is to construct the replacement Fort Garry - Wastewater Siphon Crossings of the Red River.

I approve the alteration per Section 14(2) of The Environment Act and subject to the following conditions:

- 1. The Licensee shall comply with all other applicable federal, provincial, and municipal regulations and by-laws.
- The Licensee shall submit written notification to the designated Environment
 Officer of the Environmental Approvals Branch prior to the commencement of
 work and upon project completion.
- 3. The Licensee shall submit a construction completion report and "Record Drawings" to the designated environment officer within four months of completion of the construction work.
- The Licensee shall submit a plan to decommission the Emergency Bypass System after the new Wastewater Siphon Crossings of the Red River are commissioned.
