The Rural Municipality of Springfield advises the "Dust Abatement Policy" outlines the following items. A complete copy of the policy is available on our weste at www.rmofspringfield.ca, or at the Public Works Department.

The policy outlines a minimum of 100' and a maximum of 500' per residence at a 50% cost share with the RM. The ratepayer will be responsible for 100% of the cost over 500' per residence.

The RM will not be responsible for any dust control placed by the ratepayer if bladed through by the RM whether or not the ratepayer has notified the RM of its placement.

The deadline will be June 1 annually to qualify for the 50% cost share, all orders after that date will be at a 100% cost to the ratepayer. You must attend in person at the Public Works Department at 27 055 Oakwood Road 64N to place your order. Orders can be placed any time after January 1. The Department accepts cash or cheque only.

The cost to residents before June 1 is \$0.40 cents per lineal foot for two passes, and doubles to \$0.80 cents per lineal foot after June 1.

The Public Works office is open Monday to Thursday from 7:00 am to 4:30 pm and Friday from 7:00 am to 3:30 pm, each day the office is closed during the lunch hour from noon to 12:30 pm.
