March 26, 2010	Letter from Manitoba Hydro to Peguis First Nation indicating Manitoba Hydro would contact Peguis First Nation regarding setting up a Bipole III EPP meeting
May 17, 2010	Fax from Manitoba Hydro to Peguis First Nation indicating that they would like to set up a meeting to provide an update on Bipole III
July 7, 2010	Letter from Peguis indicating that Peguis is interested in participating in the consultation activities for Bipole III in particular a land use study
August 8, 2010	Letter and newsletter from Manitoba Hydro advising that a final preferred route for the Bipole III Transmission line has now been selected and indicating that Manitoba Hydro could share project information
March 15, 2013	Meeting with Peguis First Nation to discuss building a working relationship for future projects
June 26, 2013	Response from Manitoba Hydro to Councillor Sutherland's May 17, 2013 letter
July 4, 2013	Follow up meeting with Peguis First Nation to discuss building a working relationship for future projects
October 7, 2013	Letter from Peguis First Nation to Manitoba Hydro sent to Peguis in response to the June 26, 2013 letter
November 20, 2014	MH sent a letter and email to Peguis First Nation requesting to meet with the community to review the EPP. The letter was accompanied with a link to the following documents: the Transmission Access Management Plan, the Bipole III Environmental Protection Plan, the Bipole III Transmission Line Construction Environmental Protection Plan (CEnvPP) for Segments S1 and S2, and the Culture and Heritage Resource Protection Plan (CHRPP). A copy of the sample questionnaire that MH uses to assist with developing a community appropriate protocol for the

	CHRPP was also enclosed. A copy of the Access Management brochure was also sent. Representatives from Peguis First Nation acknowledged receipt of the letter and email.
January 7, 2015	Meeting with Manitoba Hydro and Peguis First Nation. Peguis First Nation representatives requested that an EPP meeting be held in April.
March 25, 2015	Manitoba Hydro sent an email to Peguis First Nation to see whether Manitoba Hydro staff should work with Peguis First Nation to schedule a Bipole III Community Information Session in April.
April 7, 2015	Manitoba Hydro sent a follow-up email asking if Chief and Council are still interested in hosting a Bipole III Community Information Session in April. Manitoba Hydro has not received a response to the email.

During previous discussions with Peguis First Nation regarding Bipole III, key topics included employment and business opportunities and Manitoba Hydro did not note any EPP related concerns, however, Manitoba Hydro continues to have discussions with Peguis First Nation and looks forward to meeting to further discuss the Environmental Protection Program.
