**Re: Feedstock Trial at Enviroclean Landfill Solutions Ltd. – Licence 2999**

Environmental Approvals Branch is in receipt of your electronic correspondence of February 19, 2015, and November 16, 2015, and supporting correspondence from HyLife Foods, submitted October 27, 2015. The correspondence requests authorization to begin a 12 month trial to compost centrifuged dried biosolids from the R3 Innovations Inc. and Town of Neepawa industrial wastewater treatment facility (IWWTF) at the Enviroclean Landfill Solutions Ltd. facility in Morden, MB.

Upon review of the NoA, we have determined that the potential environmental effects of the trial are insignificant and therefore I have decided pursuant to Section 14(2) of *The Environment Act* to approve the proposed 12 month trial pursuant to the following conditions:

1. Upon completion of the 12 month trial, a report summarizing results, volumes of feedstock utilized, volumes of compost created, analytical results of the compost and what the compost was used for or if it was sold.
2. The Licencee shall not store any feedstock material from the IWWTF outdoors.
3. The Licencee shall only accept IWWTF feedstock in sealed containers, and shall process the feedstock within 12 hours of receiving it.
4. The Licencee shall notify the assigned Environment Officer no less than 5 days prior to receiving the first load of feedstock from the IWWTF.
5. This approval is in effect for 12 months from the date of receiving the first load of feedstock from the IWWTF.
6. The Licencee shall notify the assigned Environment Officer within 10 days if either party (Enviroclean, R3 Innovations or Town of Neepawa) cancels this trial within the 12 month timeframe requested.
