**Re: Target Products Ltd– Notice of Alteration**

Thank you for your Notice of Alteration (NoA) dated July 22, 2014 for the Target facility located at 400 Pandora Ave. west in Winnipeg. The proposed alteration consists of: installing heavy duty tarp over the dryer discharge canopy and around the dryer control platform; and, construction of a weather canopy for the dryer control platform. The purpose of this alteration is to control and mitigate fugitive dust emissions and to provide a shade to the dryer control platform.

Upon review of your alteration request, I have concluded that the environmental effects of the proposed alteration will be insignificant, and, therefore, in accordance with Section 14(2) of *The Environment Act* you are hereby authorized to carry out the proposed alteration as described in your Notice of Alteration.

**RE: Manitoba License No. 3024 – Target Products Ltd. Notice of Alteration**

Further to our emails regarding the above-mentioned, please consider this documentation as our Notice of Alteration for two (2) minor changes to our dryer support mechanism. Neither of the changes alters the performance of the dryer burner mechanism, dryer operation in and of itself, capacity or design nor are there changes in the aggregates we dry.

The changes are as below-noted.

**Dryer Discharge Conveyor Cover**

The dryer discharge conveyor delivers dried sand or rock aggregate material from the dryer drum itself to the aggregate delivery bucket elevator for internal storage in one of the four (4) internal chambers of the Imperial Silo. The conveyor employs a canopy running the length of the mechanism however, this canopy was inadequate for keeping dust to a minimum considering the wind gusts emanating through the equipment in general at the south side of our property.

We have installed a heavy duty tarp over the dryer discharge canopy to ground level to increase the negative air pressure of the aggregate bucket elevator and the dryer itself to increase the intake of dust into the aggregate bucket elevator and dryer baghouses respectively. We have also installed a tarp around the base of the dryer control platform to keep sand from swirling to the south of our property.

Due to concerns raised by our neighbor to the south, we felt this alteration essential in capturing any dust coming from the discharge conveyor as well as curtailing sand swept by north winds through our yard.

To date, we are pleased with the performance of this tarping.

**Proposed Dryer Control Platform Weather Canopy**

The dryer control platform location is on the east side of the dryer drum. The platform is home to the burner, electrical controls, gas fittings/lines and blower mechanism for the dryer. All mechanisms are weather proof and meet Manitoba Hydro and City of Winnipeg specifications.

We propose to erect a simple metal framed canopy running the length of the dryer control platform from the burner mechanism to the end of the blower located on the east side of the dryer mechanism (approximately 7 feet from platform base and 8 feet in length). The canopy will not have any sides so as to restrict airflow through the blower or dryer intake – it simply acts as a weather guard from above and as recommended by the City of Winnipeg Fire Commissioner.

The proposed canopy will be constructed with 1.5" square steel tubing with a 20-gauge steel roofing panel.


