APPENDIX B CONSULTATION NOTIFICATIONS

PROPOSED MADISON 115 – 24 kV STATION PROJECT

Public Notification

To ensure a reliable electrical supply to customers in the St. James area into the future, Manitoba Hydro is proposing to construct a new 115 – 24 kilovolt (kV) station. The site for the proposed station is located on Manitoba Hydro owned property at 555 Madison Street, south of Ellice Avenue near Century Street, in the City of Winnipeg. The site is located to the west of an existing Manitoba Hydro right-of-way (see map on the back of this page). The new station is required to address load growth in the area, as well as safety and reliability issues associated with the existing St. James Station (located south of the proposed station site at St. James Street and Portage Avenue) which is aging.

The project will also involve termination of three existing 115 kV transmission lines which currently terminate at St. James Station into the new station. This will require approximately 2.0 km of new 115 kV underground transmission line be installed in the existing Manitoba Hydro right-of-way from a point south of St. James Station to the new station. In addition, 24 kV feeder lines will be constructed from the new station to tie into existing feeder lines that provide electricity to local residences and businesses. The feeder lines will be routed underground from the station and, once outside of the station, most will be routed towards the existing St. James Station to tie into existing feeders in proximity to the station. Other feeder lines will tie into existing feeders around the new station. In order to connect the new station feeders to the existing feeders, a new duct line will need to be constructed along Madison Street to Ness Avenue. The existing building at 555 Madison Street will be demolished.


The proposed Madison Street Station has an anticipated in-service date of 2015. Construction activities are planned to get underway in 2013. Development of the proposed Madison Street 115 – 24 kV Station Project will require a Class 2 licence under *The* (Manitoba) *Environment Act*. The environmental impact assessment for the project, including the process of public consultation, will be documented in an environmental assessment report. The report, together with an Environment Act Proposal Form (EAPF), will be submitted to Manitoba Conservation as application for the Manitoba Environment Act licence.




- Three existing 115 kV transmission lines will be terminated into the station:
 - An existing 115 kV underground line from St. James to Sherbrook
 Stations will be spliced south of St. James Station, and extended to
 new station with approximately 1.5 km of new underground line on
 existing Hydro right-of-way.
 - An existing 115 kV line from Rosser to St. James Stations (RS51), located immediately east of new station, will be sectionalized at the new station to create two new lines – one running north and one running from the south.
 - The line running from the south will be connected to the new station by a splice of the existing 115 kV line from LaVerendrye to Mohawk Stations south of St. James Station.

Sectionalization of Existing 115 kV Transmission Line

- To terminate the LaVerendrye to Mohawk Stations & Rosser to St. James Stations lines into the new station, additional underground structures will be installed.
- The underground structures will be installed at the existing St.
 James to St. Matthews Terminating Structure.
- All equipment and underground structures required to terminate the lines will be located on existing Manitoba Hydro property.

24 kV Feeder Lines

- Project will require connecting existing 24 kV feeder lines into the new station.

Customer Outages

- Transfer of feeders from St. James Station to new station planned and coordinated to ensure minimal disturbances and outage times.
- Whenever possible, feeder transfers will not result in an outage to customers.
- There may be instances where a momentary interruption to customers will be required.

Traffic Effects – 115 kV Underground Line

- Between St. Matthews and Ness Avenues, a back lane east of Madison Street will be used to access the existing right-ofway.
- Access along back lane not impeded but some minor disturbances to traffic will occur.
- Construction will be short term in duration (two to three weeks).
- Businesses and residences will be advised regarding construction schedules.

Traffic Effects – 24 kV Duct Line

- Temporary interruption of traffic along Madison Street required during construction of 24 kV duct line.
- Closures will be staged in sections along Madison Street.
- Construction will be short term in duration (three to five weeks) and likely one week per section.
- After the duct line is in place and cabling has been installed, splicing will be required at Ness Avenue to connect existing feeders to the new station.
- Traffic disruptions at Ness Avenue will occur and will be approximately one week in duration.


Traffic Effects – 115 kV Splicing

- To connect two existing 115 kV transmission lines to the new station, splicing is required south of the existing St. James Station.
- One laneway immediately south of the station on Portage Avenue may need to be closed for a week.
- The sidewalk south of the station may also need to be closed for two to three weeks.
- Signage will be in place to alert pedestrians that the sidewalk will be closed for a period of time.

Environmental Licensing

- Development of the project requires a Class II license under The Environment Act (Manitoba).
- The environmental assessment for the project will be documented in an environmental assessment report.
- The report constitutes Manitoba Hydro's formal application for an environmental license.
- It is expected that the EIS will be submitted to Manitoba Conservation in late 2012.
- The environmental report will be available for public review.
