### Eshetu:

The requests for information issued July 5 and August 23 included a deadline of August 31 to provide a noise assessment and respond to other questions. We would like to request that the deadline for the responses be extended to September 28 so that we can conduct the noise assessment and provide responses to the other questions.

Following receipt of the letter dated July 16 from the Environmental Compliance and Enforcement Branch indicating that Rakowski Recycling must cease day-to-day operations relating to outdoor operations, the facility sent their mobile shear off-site.

On August 13, Environmental Compliance and Enforcement indicated that Rakowski could resume those operations permitted under the Conditional Use Order so as to proceed with the noise assessment. As the mobile shear is currently off-site, arrangements must be made to have it delivered to the site to conduct the noise assessment.
