Re: Manitoba Hydro - Manitoba-Minnesota Transmission Project

I am writing this letter on behalf of the Province of Manitoba as part of the subject regulatory review. On November 6, 2013, in accordance with section 58.17 of the National Energy Board (NEB) Act, Manitoba Order In Council No.: 00386 / 2013 designated the Minister of Sustainable Development (formerly Conservation and Water Stewardship) as the provincial regulatory agency for the Manitoba Hydro, Manitoba-Minnesota Transmission Project (Project).

Manitoba Hydro submitted an application to Manitoba Sustainable Development for a licence pursuant to The Environment Act for the Project on November 21, 2014. Manitoba Sustainable Development subsequently carried out an environmental assessment process for the Project in accordance with The Environment Act and initiated Crown consultations with Indigenous communities.

The environmental assessment process consisted of an environmental assessment coordinated by the Environmental Approvals Branch and public hearings conducted by the Clean Environment Commission, which were held in the spring of 2017. This process involved over 750 information requests from the commission and funded participants (seven) and associated responses that were completed prior to the start of the oral hearing. The oral portion of the process was an 18 day public hearing which involved numerous presentations and cross examination with funded participants. There were also 2 public sessions where the public could bring their concerns forward to the Clean Environment Commission. This could also be done in writing should people be unable to attend the sessions.

The result of the Clean Environment Commission hearings for the project is a summary report which was submitted to the Minister in August of 2017. The Minister of Sustainable Development will consider the results of the Environmental Approvals Branch's environmental assessment process, the Clean Environment Commission public hearings and summary report, and Crown consultation of Indigenous communities prior to making a licensing decision for the Project.

Crown consultation with Indigenous communities for the Project took place in parallel with the environmental assessment and Clean Environment Commission processes and is ongoing. Once completed, a summary of the consultation process will be provided to the Minister and at that point in time, she will have the information needed to make a licensing decision. We anticipate the final consultation report in February 2018.

On December 16, 2016, Manitoba Hydro applied to the National Energy Board (NEB) for a permit pursuant to section 58.11 of the NEB Act for the Project. In accordance with subsection 58.14(2) of the NEB Act, the NEB has indicated it will seek to avoid the duplication of measures taken in relation to the Project by the provincial government. For the NEB's consideration in respect to the avoidance of duplication, I refer you to information on the environmental assessment process pursuant to The Environment Act and the Crown consultation process undertaken for the Project by Manitoba Sustainable Development.

To aid the NEB in their review of Manitoba's process, a list of pertinent documents located on this webpage is provided in the attached Appendix.

In Manitoba, Crown consultation with Indigenous communities is carried out independent of the environmental assessment process. Information on Manitoba's Crown consultations for the Project will be shared with the NEB in accordance with the terms of reference for the coordination of Crown consultations between the Province of Manitoba and Natural Resources Canada Major Projects Management Office (MPMO).

If you have any questions regarding this information, Manitoba is pleased to communicate with the NEB regarding the Project consistent with section 18 of CEAA, 2012. I trust this will assist the NEB in fulfilling its obligations to avoid duplication in the regulatory process.
