SUBJECT: Observations and Comments on Environment Act Proposal (Client File No. 5762.00)

Cormer Group Industries - Military Vehicle Repair and Overhaul Facility

No. 1445 Church Avenue, Winnipeg

Environmental Compliance and Enforcement Branch has reviewed the Environment Act Proposal (EAP) report for the above noted facility. The observations and comments are as follows:

<u>Description of the Proposed Development:</u>

1. Under description of development, the following were not provided.

- a) Adjacent land uses.
- b) Land use designation of the site.
- c) Complete floor plan was not provided in the report indicating different parts of the facility and hazardous chemicals and hazardous waste storage locations.
- d) Description of storage of procedures of coolants, oils and other chemicals.
- Detail of methods of storage of hazardous waste generated within the facility and the safe guards provided were not given in the report.
- 3. Noise levels within the facility and outside the facility are not discussed in the report.
- 4. The hazardous waste generator registration number referred (page 1, last para under section 1) is incorrect and Hazardous waste registration number allocated for 1445 Church Street location is MBG12612. Further, apprendix I is only a copy of a manifest and found to be illegible to understand the details.

Description of Environmental and Health Effects

- 5. Although the MSDS of coolants and oil are annexed to the EAP report, anticipated environmental and health effects of coolants and oil must be discussed under Environmental and Human effects, in order to understand any significant effects during accidental releases.
- 6. It is much desired, if the significance for potential and chronic impacts to health or environment from exposure to concentrations of the compounds detected or any worse case scenarios is discussed as part of the assessment.
- 7. The MSDS of all paints indicate that they emit volatile organic carbon (VOC). However, analytical reports of air quality of these emissions were not attached to assess the impacts of such air emissions.
- 8. It was mentioned that air emissions are send out to atmosphere through roof top exhaust systems (page 2, last para) after going through a filter system. However, the detail of this air pollution control device or devices installed in the facility was not given in the report.
- 9. It was not stated what level of training is provided for health, safety and environmental considerations and who provide such training.

10. Emergency response protocols pertaining to spills and accidents must be discussed in the report to understand the adequacies. It is not clear whether the emergency response protocols are in conformity with the requirements of Canadian Centre for Occupational Health and Safety "Emergency Response Planning Guide" or any other acceptable planning guidelines. Further frequencies for revision of such emergency response protocols not mentioned.

Monitoring and Reporting

- 11. It is not mentioned that what kind of monitoring plan is in place and what parameters of the wastewater will be monitored to meet of the approved pollution prevention plan (Appendix B & C) by the City of Winnipeg.
- 12. No mentioned about any residual environmental effects.

Additional comments - Format of the EAP report:

- 13. EAP does not contain a table of contents for easy reference of contents and appendices to the report.
- 14. A proper executive summary of the EAP report is not provided in the document. The executive summary should provide a condensed version of the longer report. It usually contains a brief statement of the contents covered in the major document, such as background information, concise analysis of environmental and health effects, mitigatory measures, main conclusions etc.
