Dear Shannon Kohler,

This letter is to inform you of the status of our notice of alteration to our license related to the manufacture of hand sanitizer in response to the COVID-19 pandemic.

For your records, we have attached the written agreement to the temporary modifications from Ed Traa, Senior Fire Inspector, Winnipeg Fire Department, dated June 4th, 2020.

We have completed the planned modifications to one of the 14,000L poly tanks and are commencing initial manufacturing-scale batches.

Following discussions with the Public Health Agency of Canada, it is our intention to continue to manufacture the hand sanitizer product on a permanent basis. We are currently evaluating potential manufacturing methods and facility modifications for the permanent solution. We anticipate that the design and selection of the permanent solution will be complete by early August. We will include the design and environmental assessment with the submission of a Notice of Alteration to the Director at that time. The manufacturing equipment will be procured once the approval is received, with a planned implementation for manufacturing by October 30th, 2020.

Due to the duration of the design, equipment procurement and renovation work required for the permanent hand sanitizer manufacturing system, we are requesting an extension of the temporary use system until November 20th, 2020 to provide uninterrupted supply of hand sanitizer to the market.

Thank you for the report addressing the temporary use of a 14000 litre poly tank for the production of hand sanitizer. The upgrades you have proposed address the static electricity concerns when using Poly tanks for a flammable liquid. We will accept your report for the interim use until the new tank is installed. There will be **no permit requirement at this time**, however could you send me a copy of the report with your seal on it? As with all tanks, a City of Winnipeg permit will be required for the installation of the new stainless tank before installation.
