COMMENTS FROM THE TECHNICAL ADVISORY COMMITTEE:

Manitoba Sustainable Development-Compliance and Enforcement Branch

Comments included leachate pond construction, potential for escape of leachate overland from pond, groundwater use, potential for soil treatment, planning for landfill gas recovery, compost utilization and soap stock pond decommissioning. For the full text see the public registry *Disposition:*

Information forwarded to proponent, and the following addresses each item identified:

- clauses 39-48 address construction of clay and synthetic lined components;
- clauses 62-64 address leachate and 69-71 address surface water;
- the Office of Drinking Water reviewed the proposal and provided comments regarding potable water;
- the was no request for operation of a soils treatment facility, if the Licencee wishes to treat soils at this location, a Notice of Alternation will be required to be submitted;
- landfills of this size currently are not required to capture landfill gas, but recovery is not restricted;
- clause 61 addressed end use of compost; and
- clauses 31 and 32 address the Soap Stock ponds.

Manitoba Sustainable Development- Water Control Works Licensing Section

Any water control works (drains, culverts, dykes, dams, etc) associated with this project will require licensing under the *Water Rights Act*.

PUBLIC HEARING:

A public hearing was not requested and is not recommended.

CROWN-INDIGENOUS CONSULTATION:

The Government of Manitoba recognizes that it has a duty to consult in a meaningful way with Indigenous communities when any proposed provincial law, regulation, decision or action may infringe upon or adversely affect the exercise of the Indigenous rights of that community.

This is an existing facility which is located in an agricultural area. There would be no infringement of Indigenous rights under Section 35 of the Constitution Act, 1982. Therefore, it is concluded that Crown-Indigenous consultation is not required for the project.

RECOMMENDATION:

The Proponent should be issued a Licence for the continued operation and expansion of the waste disposal ground in accordance with the specifications, terms and conditions of the attached draft

Licence. Enforcement of the Licence should be assigned to the Environmental Compliance and Enforcement Branch of Manitoba Sustainable Development.
