Review of the proposal that the Proposal is for the development of new water treatment for the communities of Russell and Binscarth. Comments from the IRMT with regard to the proposal are as follows:

• It is noted that there is no biological survey completed for the study area and no justification has been provided to indicate why it has not been done. It is recommended that a survey of vegetation, and breeding bird surveys

- Was there consideration to other methods of disposal for reject material to accommodate water treatment.
   IRMT has asked why consideration was given to Spear Lake only, and not other nearby lakes like Moon and Lauder.
- There is no mention of what the accumulated volumes or identified types of minerals anticipated from the reject pipeline into Spear Lake.
- Within the section of Mitigation Measure and Residual Environmental Effects, it is noted that there is no
  discussion about the long-term implications to the fish or their flesh as to exposure to the accumulated levels of
  iron, arsenic, and magnesium (elements identified bases on current water chemistry). IRMT would like to ask if
  that can be provided.
