Transfer Station Operating Permit

In accordance with the Waste Management Facilities Regulation, made under The Environment Act, the **City of Winnipeg** is hereby permitted to operate a **Transfer Station**, to be known as the **4R Winnipeg East Depot – Panet Road Resource Recovery Centre** situated at **429 Panet Road** in the City of Winnipeg, Province of Manitoba.

THIS OPERATING PERMIT is subject to being AMENDED, SUSPENDED or REVOKED under section 7 of the Waste Management Facilities Regulation.

THIS OPERATING PERMIT is issued subject to the following TERMS AND CONDITIONS:

Definitions

In this Permit,

"noise nuisance" means an unwanted sound, in an affected area, which is annoying, troublesome, or disagreeable to a person:

- a) residing in an affected area;
- b) working in an affected area; or
- c) present at a location in an affected area which is normally open to members of the public;

if the unwanted sound

- d) is the subject of at least 5 written complaints, received by the Director in a form satisfactory to the Director and within a 90-day period, from 5 different persons falling within clauses a), b) or c), who do not live in the same household; or
- e) is the subject of at least one written complaint, received by the Director in a form satisfactory to the Director, from a person falling within clauses a), b) or c) and the Director is of the opinion that if the unwanted sound had occurred in a more densely populated area there would have been at least 5 written complaints received within a 90-day period, from 5 different persons who do not live in the same household; and

"odour nuisance" means a continuous or repeated odour, smell or aroma, in an affected area, which is offensive, obnoxious, troublesome, annoying, unpleasant or disagreeable to a person:

- a) residing in an affected area;
- b) working in an affected area; or
- c) present at a location in an affected area which is normally open to members of the public;

if the odour, smell or aroma

- d) is the subject of at least 5 written complaints, received by the Director in a form satisfactory to the Director and within a 90-day period, from 5 different persons falling within clauses a), b) or c), who do not live in the same household; or
- e) is the subject of at least one written complaint, received by the Director in a form satisfactory to the Director, from a person falling within clauses a), b), or c) and the Director is of the opinion that if the odour, smell or aroma had occurred in a more densely populated area there would have been at least 5 written complaints received

within a 90-day period, from 5 different persons who do not live in the same household.

General Terms and Operating Conditions

1. This permit expires on **August 31, 2022**.
2. The Operator shall maintain and operate the 4R Winnipeg East Depot – Panet Road Resource Recovery Centre (the Facility) in accordance with the most current version of the Waste Management Facilities Regulation (M.R. 37/2016) and this Operating Permit.
3. The Operator shall maintain a copy of the operations manual developed pursuant to M.R. 37/2016 and a copy of this Operating Permit at the Facility or the premises from which the Facility is managed.
4. The Operator shall obtain approval in writing from the Director for any proposed alterations to the Facility before proceeding with the alteration.

Site Access and Control

5. The Operator shall provide site supervision when the Facility is open to the public.

Noise and Odour

6. The Licencee shall not cause or permit a noise nuisance to be created as a result of the construction, operation, or alteration of the Development, and shall take such steps as the Director may require to eliminate or mitigate a noise nuisance.
7. The Licencee shall not cause or permit an odour nuisance to be created as a result of the construction, operation, or alteration of the Development, and shall take such steps as the Director may require to eliminate or mitigate an odour nuisance.

Materials Acceptance and Handling

8. Materials collected for recycling or reuse at the Facility must be segregated and temporarily stockpiled in clearly signed designated areas.
9. The Operator shall remove any litter accumulated along the access road and around the perimeter of the site at minimum twice annually or as required by an Environment Officer.
10. The Operator shall not bury any waste at the Facility.
11. The household waste deposited at the site shall be removed at minimum every 30 days or at a frequency required by an Environment Officer.

Dangerous Goods

12. The Operator shall collect and dispose of hazardous waste in accordance with The Dangerous Goods Handling and Transportation Act, other Provincial and Federal Regulations.

Surface Water

13. The Operator shall not release any liquids from the Retention Pond to a surface water course, without approval from an Environment Officer.
14. If not directed to a wastewater collection system or other licenced treatment facility, any wastewater that is collected in sumps or containment areas must be tested prior to being released from the Facility.


Environmental Emergency Reporting

15. The Operator shall, in the event of a fire which continues in excess of thirty (30) minutes, report the fire to the Environmental Emergency Response line by calling 1-855-944-4888 and identify the type of material involved and the location of the fire.

Burning of Combustible Waste

16. The Operator shall not allow burning at this Facility.
