# Transfer Station Operating Permit

Following the Waste Management Facilities Regulation under The Environment Act, the Rural Municipality of Lakeshore is hereby permitted to run the Makinak Waste Transfer Station (facility) located on portions of SE 17-23-16 WPM within the Rural Municipality of Lakeshore, Province of Manitoba. Schedule A of this permit identifies the facility.

This permit is subject to being amended, suspended, or revoked under sections 7 and 9 of the Waste Management Facilities Regulation.

#### **General Terms and Operating Conditions**

- 1. This permit expires on April 12, 2028.
- The operator must maintain and operate the facility following the Waste Management Facilities Regulation and any future amendments thereof, and this permit.
- 3. The operator must obtain approval in writing from the director under The Environment Act before altering the facility.

### Materials Acceptance and Handling

- 4. The operator must segregate materials collected for recycling or reuse, and must temporarily stockpile these materials in clearly signed designated areas. These areas must be maintained to control weeds, vectors, and the quality of the materials.
- 5. The operator must remove all materials received at the facility regularly or upon the request of an environment officer, within the timeframe specified.
- 6. The operator must not accept any livestock or other animal mortalities at the facility.

#### **Hazardous Wastes**

7. The operator must collect and dispose of any hazardous waste following The Dangerous Goods Handling and Transportation Act, and other federal, provincial, and municipal regulations.

#### **Surface Water Management**

8. The operator must construct the facility such that all uncontaminated surface water flows to the perimeter ditch and impacted water from all material storage areas is contained within the facility boundaries.

### **Burning of Specified Waste**

- 9. The operator must only burn:
  - a) separated and readily combustible materials such as boughs, leaves, loose straw, paper products, cardboard, non-salvageable untreated wood, and packing materials derived from wood; and
  - b) only when there is an appropriate volume of materials as identified in clause 9 (a).

## Composting

10. The operator must not allow composting at the facility.

#### Revocation

11. This permit replaces Permit No. 35500 P1, which is hereby rescinded.
