Transfer Station Operating Permit

In accordance with the Waste Management Facilities Regulation, made under The Environment Act, The Rural Municipality of Victoria Beach is hereby permitted to operate a Transfer Station to be known as the RM of Victoria Beach Waste & Recycling Depot (Facility) located on portions of NW 10-20-7 EPM within the Rural Municipality of Victoria Beach.

THIS PERMIT is subject to being AMENDED, SUSPENDED or REVOKED under sections 7 and 9 of the Waste Management Facilities Regulation.

THIS PERMIT is issued subject to the following TERMS AND CONDITIONS:

General Terms and Operating Conditions

- 1. This Permit expires on January 31, 2027.
- 2. The Operator shall maintain and operate the Facility as identified in Schedule A of this Permit in accordance with the Waste Management Facilities Regulation and any future amendments thereto, and this Permit.
- 3. The Operator shall develop an Operations Manual, within 12 months of the date of this Permit, detailing the operation and maintenance for this Facility in accordance with the Waste Management Facilities Regulation and any future amendments thereto. This manual should include but not be limited to a detailed list of the following: waste and recyclable materials accepted; emergency and safety procedures; materials not accepted; materials diverted to; and maintenance and closure activities. The Operator shall provide the Manual to an Environment Officer upon request.
- 4. The Operator shall maintain at the Facility, unless otherwise approved in writing by an Environment Officer:
 - a) a copy of the Operations Manual developed in accordance with clause 3 of this Permit; and
 - b) a copy of this Permit.
- 5. The Operator shall obtain approval in writing from the Director of Environmental Approvals Branch for any proposed alterations to the Facility before proceeding with the alteration.

Site Access and Control

6. The Operator shall restrict access to the Facility when site supervision is not provided, with a locked gate, barrier or other system approved in writing by an Environment Officer.

Materials Acceptance and Handling

- 7. The Operator shall segregate materials collected for recycling or reuse, and shall temporarily stockpile these materials in clearly signed designated areas. These areas must be maintained to control weeds, vectors and quality of the materials.
- 8. The Operator shall remove the materials identified in clause 7 of this Permit regularly or upon the request of an Environment Officer, within the timeframe specified.
- 9. The Operator shall remove any litter accumulated along the access road and around the perimeter of the site. Litter collection shall occur at minimum twice annually or as required by an Environment Officer.
- 10. The Operator shall not bury or permanently dispose of any materials at the transfer station without obtaining any written authorization from an Environment Officer.
- 11. The Operator shall remove the household waste deposited at the Facility at minimum every thirty (30) days or at a frequency required by an Environment Officer.
- 12. The Operator shall implement control measures to prevent attraction and sustenance of rodents and scavenging vectors.
- 13. The Operator shall not accept any livestock or other animal mortalities at the Facility.

Solid Waste

14. The Operator shall dispose of all non-hazardous solid waste collected at the Facility, which is not recycled, only to a waste disposal ground operating under the authority of a permit issued pursuant to Waste Management Facilities Regulation or any future amendment thereof, or a licence issued pursuant to The Environment Act.

Hazardous Wastes

15. The Operator shall not collect, store, or dispose of hazardous waste at the Facility.

Surface Water Management

16. The Operator shall construct the Facility such that all uncontaminated surface water flows to the perimeter ditch and impacted water from all material storage areas is contained within the Facility boundaries.

Site Construction

17. The Operator shall construct the Facility in accordance with the site plan and additional information dated November 18, 2021.

Burning of Combustible Waste

18. The Operator shall not allow burning at the Facility.

Composting

19. The Operator shall not allow composting at the Facility.
