Re: Manitoba Hydro-Grand Rapids Fish Hatchery Upgrade and Expansion

I am writing to you on behalf of the Manitoba Metis Federation ("MMF")—which is the democratically elected self-government representative of our Manitoba Metis Community (our "Community")—to outline the MMF's concerns with respect to Manitoba Hydro-Grand Rapids Fish Hatchery Upgrade and Expansion (the "Project"). Specifically, the MMF is deeply concerned with the lack of consultation and respect shown by Manitoba Sustainable Development ("MSD") for the concerns of our Community and the impacts of the Project on our constitutionallyprotected rights, interests, and responsibilities.

To date, the MMF has not been consulted or notified by MSD regarding the Project. We have had no discussions regarding the impacts of the Project on the constitutionally projected rights, interests, and claims of our Community, how to mitigate such impacts, or to discuss and implement collaborative processes that respects our ongoing stewardship rights and responsibilities towards our traditional Metis territory on which the Project is located. This is entirely unacceptable. As further set out below, a respectful process of consultation with the MMF, on behalf of our Community, is clearly required, long overdue, and should begin immediately.

Our Manitoba Metis Community is an Indigenous community and Aboriginal people within the meaning of section 35 of the Constitution Act, 1982. Based on our emergence as a distinct Indigenous people in the Northwest prior to Canada becoming Canada, and Manitoba becoming Manitoba, our Community holds rights, interests, and claims throughout and beyond the province of Manitoba. Since 1982, our rights as Metis people have been recognized and affirmed as protected by section 35 of the Constitution Act, 1982. Some of our rights have been recognized by the courts (see for example, R. v. Goodon) and through agreements with the Crown (see for

example, the Manitoba Government-MMF Points of Agreement on Metis Harvesting in Manitoba, 2012). Our Citizens, including Harvesters, rely on and use the lands, waters, and resources of our traditional territory throughout the province of Manitoba—including in the area of the Project—to exercise their constitutionally-protected rights and maintain their distinct Metis customs, traditions, and culture.

The MMF is mandated to promote, protect, and advance the collectively held Aboriginal rights of our Manitoba Metis Community, including by engaging with governments, industry, and others about potential impacts of projects or activities on our Community. In 2007 the MMF adopted Resolution No. 8 that sets out the framework for engagement, consultation, and accommodation with our Community. Designed by Metis—for Metis—Resolution No. 8 sets out the process that is to be followed by governments, industry, and other proponents when developing plans or projects that have the potential to impact the section 35 rights, claims, and interests of our Community. It was unanimously passed by MMF Citizens and mandates a "one-window" approach to consultation and engagement with our Manitoba Metis Community through the MMF Home Office.¹

In consulting the MMF, on behalf of our Community, the Resolution No. 8 Framework calls for the implementation of five phases:

Phase I: Notice and Response; Phase II: Funding and Capacity;

Phase III: Engagement and Consultation;

Phase IV: Partnership and Accommodation; and,

Phase V: Implementation.

We understand that the Project will involve the expansion and upgrade of the Grand Rapids fish hatchery. This includes the construction and upgrade of infrastructure and the improvement of biosecurity protocols. There was an assessment of the potential effects from construction and operation; however, the MMF has been given no information regarding this assessment or has had no discussions about any permits or licenses applied for. The MMF is extremely disappointed that you have not consulted with us about the Project and its impacts on our Manitoba Metis Community's rights, claims, interests, and responsibilities as stewards of our traditional territory.

The proposed Project is located entirely within our traditional Metis territory. It is in an area in which the provincial Crown has recognized the section 35 Metis harvesting rights of our community, including hunting, trapping, fishing, and gathering for food and domestic use, including gathering timber. Our Citizens, including Harvesters, continue to use and rely on this area to exercise their rights today. The proposed Project is therefore expected to have an impact on the rights, claims, and interests of our Community and, as such, consultation with the MMF through the processes as set out above will need to be followed.

We would like to arrange a meeting between representatives of the MMF and MSD to discuss the Project and a process for ensuring the MMF is appropriately notified, consulted, and involved in Project-related opportunities. It is imperative that the MMF is informed as to the Project's potential impacts, both positive and negative, to our Community and their use of the lands, waters, and resources. The MMF looks forward to your response and to working collaboratively with you on this Project to ensure Metis-specific information and concerns are incorporated into a full, proper, and meaningful consultation process with our Community.
