- Can you provide more information on the actual physical distance from residences and schools? It appears from the map that a school is about 300 M away. The map shows a number of buildings near the facility. Can the purpose of these structures be outlined? Is this an industrial area?
- Can you provide more details about the building where the waste will be held? Will anything be stored outside? What is the anticipated volume of traffic to the facility and how will it be managed? Has the community around the site been consulted?
- The proposal indicates that compressed gas may be stored at the site, which may pose an explosion risk. Can you outline the potential fire /explosion risk with in this facility and your plans for explosion or fire within the facility? Please include a discussion of the proximity of the other buildings nearby and their use.

If at any time, however, heritage resources are encountered in association with these lands during testing and development, the Historic Resources Branch may require that an acceptable heritage resource management strategy be implemented by the developer to mitigate the effects of development on the heritage resources.
