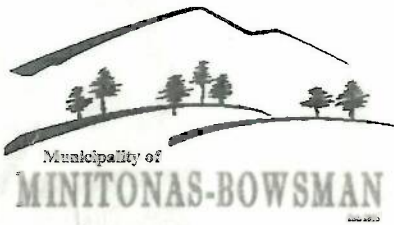

Our Waste Disposal Facilities only collect household quantities of hazardous wastes and store them in segregated sections at our landfill sites until such time as Miller Environmental picks them up. With more households utilizing propane tank exchange programs we expect quantities of these items to decrease. Regular inspections by the Authority Having Jurisdiction has demonstrated that all items, including those deemed as hazardous are received, stored and shipped in an appropriate manner.

Hello,

Further to our tele conversation today I have attached the maps for:

1. Minitonas Waste Disposal Grounds located at SW 17-36-26W (Roll #53300.000) under Certificate of Title #2487522.
2. Bowsman Waste Disposal Grounds located at Lot 1 Plan 36330, SW 24-38-27W (Roll #182000.000) under Certificate of Title #1612729. The second joining lot is located at Lot 2 Plan 36330 (Roll #182050.000) and is under Certificate of Title #1612732.

These are the exact same maps that were provided for our Waste Disposal Ground Operating Permits:

- Minitonas Waste Disposal Ground Permit No: 8698 P1
- Bowsman Waste Disposal Ground Permit No: 8622 P1

Important to note that we will no longer be collecting used waste oil at either site. Current used oil at our sites will be picked-up around the same time our Cleanfarms and propane tanks are picked-up by Miller Environmental. This means the only hazardous waste we will continue to collect is empty propane tanks (household use size) and used car batteries. The cleanfarm empty chemical containers fall under the Cleanfarms Program.

I look forward to being issued our Dangerous Goods Handling and Transportation Act as well as our waste generator number to enable us to arrange for pick-up of the above-noted items.
