RE: Vivian Sand Facility Project – Environment Act Proposal (EAP) Application

Dear Ms. Winsor,

On behalf of CanWhite Sands Corp. ('CanWhite'), enclosed is an Environment Act Proposal (EAP) application including an EAP report for the Vivian Sand Extraction Project (the 'Project'). As outlined in the EAP report, the Project will consist of extracting silica sand from the Winnipeg Sandstone aquifer in the Winnipeg Sandstone geological formation southwest of the hamlet of Vivian, Manitoba and approximately 26 km east of the City of Winnipeg from the border of the CanWhite mining claims area within the R.M. of Springfield.

The Project will not be using an open pit quarry method due to the depth of the target sand deposit. Instead, water well drilling rigs will be used to drill extraction wells and install casing to the target sand deposit. A maximum of seven extraction wells would be operating simultaneously for five to seven days each from April to November each extraction year to up and including 2025. Groundwater brought to surface with the sand will be separated from the sand, treated with ultraviolet light, and immediately returned to the original aquifer. There will be progressive decommissioning (sealing) of annual extraction wells and well cluster areas. There will also be progressive annual rehabilitation of temporarily drill rig access trails, equipment laydown areas, slurry line trails and return water line trails.
