I am an Environmental Studies student conducting research on peatland harvesting activity in Manitoba. It came to my attention that there was a proposal submitted by Sun Gro Horticulture Ltd regarding the harvesting of Evergreen Bog 1. To my understanding this is the first proposal submitted since IAA (2019) and the last one to not require an exploratory permit.

I would like to submit the following commentary on Sun Gro Horticulture Ltd's application for a PHL (File no. 628.10).

I am concerned that Sun Gro Horticulture lacks baseline data and that the firm should have some foundation, given their extensive harvesting activities in the area. Would there not be data available from Evergreen Bogs 2 and 3 that could indicate whether or not the condition of Evergreen Bog 1 is similar to its original condition prior to any extraction activities?

I am curious how this activity will increase Sun Gro's cumulative impact from their current PHLs and past quarry leases in the southern peatlands region, in Manitoba, and in Canada as a whole. If there is little to mitigate certain sources of carbon emissions during the preparation and harvesting of peatlands, how will this impact climate change goals and the safety of future generations? Moreover, why is Sun Gro intent on expanding into more peatlands in the area when they renewed their leasehold for Evergreen Bogs 2 and 3 in 2018? What level of compliance has Sun Gro shown when data has been audited or monitored by the government of Manitoba? How many days (if any) above thresholds annually does Sun Gro average? Should this be of any concern when considering the impacts of harvesting Evergreen Bog 1?

I am also curious if enough attention has been made to protected species in the bog, including the Northern Leopard Frog and whether 100m buffers will be large enough for species to safely move throughout their ecosystem. I am concerned that continuing to approve PHLs in this area will severely fragment habitats and create more concerns for wildlife.

I do not believe that this expansion of Evergreen Bog should be approved because I do not believe that climate change goals can be achieved if the total carbon emissions from a single firm or the peatland harvesting industry in Manitoba. Moreover, I believe that companies like Sun Gro should find sustainable alternatives and eliminate peat from their operations over time, as opposed to expanding these operations and contributing at a greater rate to greenhouse gas emissions and other methods of pollution from peatland harvesting.

And then there are the disclaimers;

- 1. This report is based on information made available to KGS Group by Sun Gro. Unless stated otherwise, KGS Group has not verified the accuracy, completeness or validity of such information, makes no representation regarding its accuracy and hereby disclaims any liability in connection therewith.
- 2. KGS Group prepared the geo-environmental conclusions and recommendations for this report in a professional manner using the degree of skill and care exercised for similar projects under similar conditions by reputable and competent environmental consultants.

Apparently, KGS was (1.) just following orders and (2.) was copying other "scientists".

So, why should I read 205 pages written by unaccountable people?

But I read enough to learn that KGS did an eloquent job of defining the "Environmental Issues" (see 5.2). Then it went on to a "Biophysical Effects Assessment" (see 5.3) where these scientists came to the same conclusion with regard to every single environmental risk associated with the project:

## "determined to be not significant"

Compared to what? Sun Gro's profits? KGS's fees?

The same unquantified conclusion was reached with respect to socioeconomic effects (see 5.4). Yup:

### "determined to be not significant"

This is tedious and counter-intuitive. My favourite is Aesthetic Values (see 5.4.6). Because this project won't be seen by many folks, the utter destruction of the landscape was, you guessed it:

### "determined to be not significant"

Peat mining has been called "environmentally bankrupt". It took 10,000 years of evolution to create the peat bogs which preserve our water and sequester carbon. Then along comes a corporation in search of a market, and for the most frivolous of reasons, wrenches peat from where it should remain and trucks it off to a foreign country. In the case of Sun Gro, the net profits leave the country, too.

Despite the assurances of the peat moss industry, no peat bog in Manitoba has ever been restored to its pre-mining condition. In every case all we are left with is a flooded hole in the ground. If I am mistaken, kindly send me the GPS coordinates of your "restored" bog of choice long with the statistics of its secondary production.

Despite all the damage done to water, wildlife, ecosystems and climate the Sun Gro EAP will be approved.

But thanks for the KGS scientists' conclusion that this particular endeavour will have no environmental consequences. Heck, the impact on climate is declared to be 0.0002% of Canada's emissions. Sluffing responsibility off is unscientific.

But here is what the Province of Manitoba wrote in its "Peatlands Stewardship Strategy" in 2014:

- 1. Peatlands cover 3% of the Earth's surface but contain 30% of the world's carbon.
- 2. Peat harvesting represents up to 3% pf Manitoba's greenhouse gases.
- 3. Only 250 Manitobans are directly employed in peat mining.

This is why peat mining is particularly environmentally bankrupt in Manitoba. It is a major contributor to lethal climate change and it employs a tiny number of Manitobans. The Sun Gro EAP is insulting when it reports that its impact will add 0.0002% in Canada's climate damage. It is unconscionable that the "scientists" behind this pathetic comment have ignored the cumulative effects of peat mining in Manitoba.

The EAP proves, once, again, that everybody wants to avoid climate change as long as their lifestyles are not affected.

There are other tragedies beside climate change that also reinforce the environmental bankruptcy of peat mining. They include water pollution, ecosystem damage and wildlife habitat loss all so that a needless product can be produced by relatively few people.

And there goes another Northern Leopard Frog.

There are no credits on the photographs of the site. Did KGS take them or were they provided by Sun Gro. Did KGS visit the site? If so, how many times, during which seasons and for how long?

It is disturbing that Scatlift & Miller & Murray apparently distributed literature which depicts peat mining in a positive light when consulting with "stakeholders". The "Fact Sheet" presented is grossly skewed in Sun Gro's favour. Peat moss scattered on the land does not "Improve Green Spaces". It is wholly unnecessary. "Food Production" and "Starting Seeds" is redundant.

There are serious negative consequences to stripping peat from its natural location. None of this is in the so-called "Fact Sheet".
