

Offal and Deadstock Disposal Sites

The list below includes sites which are authorized to accept offal and deadstock from livestock operations. Most other landfills, including Class 2 and Class 3 Waste Disposal Grounds prohibit carcass disposal, or can accept only small quantities with prior approval. This document provides a general overview and is only current to the date indicated below. **Information provided should be confirmed by the contact provided in advance of disposal.** Prior approval is required before shipment to any landfill (24 hour notice or more) is generally required.

² The [Canadian Food Inspection Agency](#)'s policy is that SRM material is defined as 1. The skull, brain, trigeminal ganglia (nerves attached to the brain), eyes, tonsils, spinal cord and dorsal root ganglia (nerves attached to the spinal cord) of cattle aged 30 months or older; 2. The distal ileum of cattle of all ages.
