1. Description of the drinking water system- 22.60-Folk Festival Site

The Folk festival is a public water system that operates seasonally from June to July. Ground water is drawn from two primary, secure wells and is then treated with Sodium Hypochlorite. The treated water moves through a series of chlorine tanks, to ensure the 20 minute required contact time is met.

The water is treated with a 12% Sodium Hypochlorite solution that is injected into the water with a diaphragm pump. The chlorine readings of the water leaving the facility have to have a "Free Chlorine" reading of 1.0mg/L mg/L as per the regulations. Water in the distribution system must meet at minimum, 0.1mg/L that is the free chlorine distribution standard.

Disinfectant residuals free and total are monitored daily, seven (7) days a week and bi-weekly in the distribution system. Raw water is sampled bi-weekly for various parameters set out in the applicable license All information is recorded on the appropriate monitoring forms. Monthly report forms are provided to the Province's Regional Drinking Water Officer at the end of each month. All samples are submitted bi-weekly to ALS environmental for testing.

The table below lists the water quality standards that apply to the public water system. An analytical report was compiled in August 2020, the remaining data is from monitoring during the 2022 operating season.

Ground water is drawn from two primary, secure wells and is then treated with Sodium Hypochlorite. The treated water moves through a series of chlorine tanks, to ensure the 20 minute required contact time is met.

The water is treated with a 12% Sodium Hypochlorite solution that is injected into the water with a diaphragm pump. The chlorine readings of the water leaving the facility have to have a "Free Chlorine" reading of 0.50 mg/L as per the regulations. Water in the distribution system must meet at minimum, 0.1mg/L that is the free chlorine distribution standard.

Disinfectant residuals free and total are monitored daily, seven (7) days a week and bi-weekly in the distribution system. Raw water is sampled bi-weekly for various parameters set out in the applicable license All information is recorded on the appropriate monitoring forms. 
There were no major expenses incurred to repair, replace or install equipment. The south treatment plant was upgraded 3 years ago.

1. Description of the drinking water system- 22.25-North Pump house

The North pump house is a public water system that operates year round. Ground water is drawn from two primary, secure wells and is then treated with Sodium Hypochlorite. It is then sent out into the distribution system.

The water is treated with a 12% Sodium Hypochlorite solution that is injected into the water with a diaphragm pump. The chlorine readings of the water leaving the facility have to have a "Free Chlorine" reading of 0.50 mg/L as per the regulations. Water in the distribution system must meet at minimum, 0.1mg/L that is the free chlorine distribution standard.

Disinfectant residuals free and total are monitored daily, seven (7) days a week and bi-weekly in the distribution system. Raw water is sampled bi-weekly for various parameters set out in the applicable license, all information is recorded on the appropriate monitoring forms. Monthly report forms are provided to the Province's Regional Drinking Water Officer at the end of each month. All samples are submitted bi-weekly to ALS environmental for testing.

4. Summary of any incidents of failure to meet a drinking water quality standard

Drinking water standards were met 100% of the operating season.

<u>5. A description of any drinking water safety orders issued in relation to the system, and of action taken in response to each one</u>

There were no safety orders issued to the system in the operating year.

6. A description of any boil water advisories issued in relation to the system, and of action taken in response to each one

There were no boil water advisories for the operating season.

7. A summary of any charges laid

There were no charges laid pursuant to The Drinking Water Safety Act and no more corrective actions were required.

8. A description of any major expenses incurred to repair, replace or install equipment

Upgrades are required to the north pump house treatment plant. System is failing to meet primary disinfection requirements of 20 minute chlorine contact time. This was communicated by Office of the drinking water. Request has been submitted by district staff for capital funding. Proper permit procedures and consultation with the office of drinking water will be followed before construction.

Our operators have completed training to keep and advance their licences to work effectively in this water system network. The north pump house, operates as a class 2 facility, the operator in charge has the required operator licence to run the facility.
