# Guide

### 2018 Manitoba Excellence in Sustainability Awards

The Manitoba Excellence in Sustainability Awards recognize and honour people, projects and ideas that successfully turn the principles of sustainable development into concrete, lasting achievements. Sustainable development considers the long-term consequences of decisions and actions on the environment, the economy and human health and well-being. It balances the needs of today without sacrificing the ability of future generations to meet their needs. Sustainability is the desired goal of sustainable development.

### **Award Categories**

#### Action on Climate Change, Air Quality and Energy Efficiency

Demonstrate action and achievements such as:

- · reducing greenhouse gas emissions and improving air quality
- · addressing climate change impacts and adaptations through innovation
- integrating innovations that improve energy efficiency

#### Sustainability in Water and Natural Area Stewardship

Demonstrate stewardship such as:

- enhancing or preserving watersheds and habitats for wildlife and fish
- incorporating sustainable farming and land-use practices
- advancing sustainable practices in the forest, mineral and energy sectors
- exceeding ecological restoration and reclamation requirements

#### Sustainability in Pollution Prevention and Product Stewardship

Demonstrate stewardship such as:

- preventing pollution at the source by avoiding or minimizing pollutants or waste production
- enhancing 4R (reduction, reuse, recover and recycle) initiatives for material management
- integrating sustainable use of resources, packaging and transportation
- · incorporating designing for environment or eco-design, which examines a product's entire lifecycle

#### **Education for Sustainability**

Demonstrate action and achievement such as:

- involving public or private educational programs (kindergarten to Grade 12, post secondary, adult learning) and incorporating sustainability into policies, operations and programs
- enhancing teaching and learning of/for sustainability and the adoption of sustainability policies and practices

#### **Innovation and Research for Sustainability**

Demonstrate action and achievement such as:

- providing leadership that builds or strengthens innovation for sustainability in Manitoba
- developing major research advancements that contribute to sustainability
- · implementing clean technology products and processes

#### **Champion for Sustainability**

Demonstrate action and achievement such as:

- an individual, organization or business making a notable contribution to sustainability
- · advancing sustainable practices in a community or a business sector



#### **Sustainable Community**

Demonstrate action and achievement such as:

- implementing integrated initiatives that address sustainable development practices in two or more areas.
   Projects should have environmental benefits (ex: green buildings, energy efficiency, planning, transportation, waste reduction and water conservation), social benefits (ex: improved quality of life) and economic benefits (ex: employment)
- innovation and improvements beyond business as usual

#### **Outstanding Achievement in Sustainability**

Demonstrate action and achievement such as:

- distinguished championing of sustainability in social, economic and environmental actions
- outstanding progress and contributions to sustainability over a minimum of five years
- advancing sustainability on a local, national or international scale
- leadership that has contributed to a significant and broad societal understanding of sustainability

## **Eligibility**

- The Manitoba Excellence in Sustainability Awards are open to all residents of the Province of Manitoba, any
  organization or business operating in Manitoba and initiatives taking place in Manitoba.
- Past Manitoba Excellence in Sustainability Award winners are not eligible to receive an award for the same project. Winners can re-enter, except where they have won that category for three consecutive years.
- Members of the Manitoba Excellence in Sustainability Awards evaluation panel, their immediate families and their affiliated companies or organizations are not eligible to receive an award.

### **Selection Criteria**

The awards evaluation panel will use the following criteria to evaluate all submissions:

The project or individual/collective achievement incorporates the provincial Principles and Guidelines of Sustainable Development. While all the principles may not apply to this particular project or person, no principles can be violated.

- 1. Principles of Sustainable Development
  - Integration of Environmental and Economic Decisions
  - Stewardship
  - Shared Responsibility and Understanding
  - Prevention
  - Conservation and Enhancement
  - Rehabilitation and Reclamation
  - Global Responsibility

- Guidelines of Sustainable Development
  - Efficient Use of Resources
  - Public Participation
  - Access to Information
  - Integrated Decision-Making and Planning
  - Waste Minimization and Substitution
  - Research and Innovation

- 2. The project or individual/collective achievement demonstrates:
  - sustainable environmental management
  - sound community economic development
  - benefits to human health and social well-being
  - links between the environment, economy, human health and social well-being
- Least The project or individual/collective achievement educates and raises awareness of the value of sustainable development.
- 4. The project or individual/collective achievement demonstrates measurable improvement and innovation over existing practices and displays how triple bottom-line accounting is incorporated. (Note: Triple bottom-line accounting incorporates three dimensions of performance: social, environmental and financial.)

### **Conditions**

- Submissions and nominations are evaluated by a panel of representatives from Manitoba Sustainable
  Development. The panel reserves the right to evaluate submissions in a category other than that applied in.
  Manitoba Sustainable Development approves all award winners.
- Applications and nominations are subject to a due diligence check. An individual or organization will not be considered if there is an outstanding environmental or health and safety order; if there is a criminal charge against them; or if there is an ongoing investigation.
- Initiatives resulting from a government order are not eligible for an award.
- The Province of Manitoba reserves the right to publicize results and achievements in press releases.
- The selection panel may declare a submission invalid if fraudulence or gross misrepresentation is suspected. Ineligible entries will be dismissed.
- All decisions of the evaluation panel and Manitoba Sustainable Development are final.
- Manitoba Sustainable Development, its evaluation panel and the Province of Manitoba do not bear any liability for entries that are lost or delayed.
- Winners may use the award logo in their own publicity by signing an agreement with the provincial government outlining the terms of use.

## **Application/Nomination Process**

Complete the application/nomination form and include a brief, typewritten description of the individual/collective achievement (maximum five pages). Describe how the accomplishments meet the selection criteria for the Manitoba Excellence in Sustainability Award. You may attach any supporting material you wish (maximum five pages). You may include up to two letters of support from people or organizations who have observed the benefits of the individual/collective efforts.

Deadline for applications/nominations is noon, Friday, February 1, 2019.
