**NOTICE OF ENVIRONMENTAL INVESTIGATION
35 SUTHERLAND AVENUE, WINNIPEG, MB**

Manitoba Hydro is planning to install an underground electrical line from its Rover Street Station to its new Burrows Station. One of the routes considered is along Annabella Street and Sutherland Avenue.

A subsurface investigation is planned for December 20 to December 22, 2010. The investigation will comprise the drilling of boreholes, collection of soil samples, and installation of monitoring wells along Annabella Street and on Manitoba Hydro property. Soil samples will be selected and submitted for laboratory analysis based upon observations at the time of drilling. Manitoba Hydro will forward Manitoba Conservation copies of the analytical results from the soil samples. Ongoing monitoring of newly installed wells will be integrated into the overall management plan for the entire Sutherland Avenue site. Please contact me at 360-4301 if you wish to discuss this investigation further.

Manitoba Hydro will complete this work using internal personnel who are very familiar with the Sutherland property.
