  - (c) Completed quarry return(s) for each lease.
- 3. If the transferor is a CORPORATION, additional requirements in accordance with subsection 216(4) of The Act must be submitted.
- 4. If the transferee is a CORPORATION, the corporation must be registered to do business in Manitoba.
- 5. Must be registered in IMAQs.
