#### SoW – MB Wildlife Branch – 'species of concern'

The Manitoba Conservation Data Centre (CDC) is a storehouse of information on Manitoba's biodiversity – its plant and animal species, as well as its natural plant communities. Housed within the Wildlife and Ecosystem Protection Branch of Manitoba Conservation, the CDC is Manitoba's authoritative source of information on rare species, including Species at Risk. The information has many uses, including conservation and development planning, and is made available to government agencies, the private sector, and the public.

The Manitoba CDC is a member of NatureServe, a network of over 80 similar organizations throughout Canada, the United States and Latin America. NatureServe and its member programs use a scientifically- and empirically-defined methodology and rigorous standards common to all CDC's throughout the network. The CDC exchanges its biodiversity data annually with NatureServe, thereby gaining access to the expertise of a team of biodiversity scientists throughout the western hemisphere.

The CDC has developed lists of plant and animal species and plant communities, also known as 'elements' of biodiversity, found in Manitoba. It assigns each of these elements a conservation status rank, based on how rare the species or community is in Manitoba, and then collects detailed information on where the provincially-rare elements have been found. These locations, known as element occurrences, are mapped using specialized geographic information system (GIS) and database software known as Biotics.

The following information on species occurring within Manitoba's watersheds is based on existing data known to the Manitoba CDC at the time of the request. These data are dependent on the research and observations of CDC staff and others who have shared their data, and reflects our current state of knowledge.

An absence of a data in any particular geographic area does not necessarily mean that species or ecological communities of concern are not present; in many areas, comprehensive surveys have never been completed. Therefore, this information should be regarded neither as a final statement on the occurrence of any species of concern, nor as a substitute for on-site surveys for species as part of environmental assessments.

Also, because the Manitoba CDC's Biotics database is continually updated and because information requests are evaluated by type of action, any given response is only appropriate for its respective request. The Manitoba CDC should be contacted for an update on this natural heritage information if more than six months passes before it is utilized.
